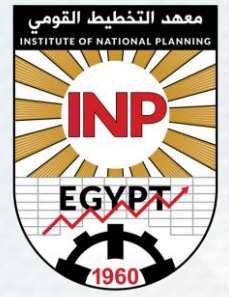

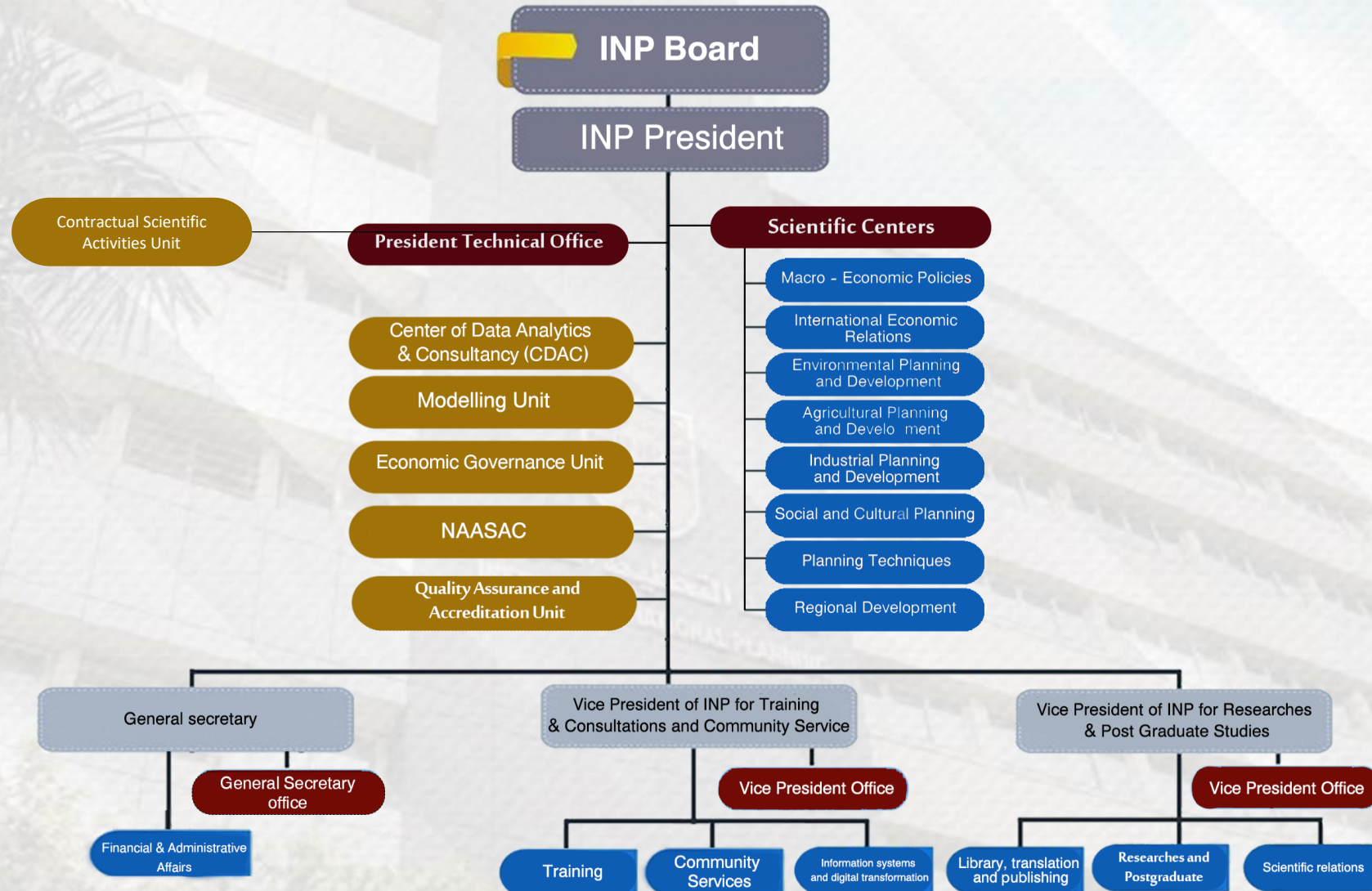

North African Applied Systems Analysis Center (NAASAC)

Goal:

The center was established as a collaborative initiative between INP, the Academy of Scientific Research and Technology (ASRT), and the International Institute for Applied Systems Analysis (IIASA) in Vienna. Its goal is to build capacity in North Africa for the application of systems thinking and systems analysis, while fostering a culture of evidence-based decision-making and promoting this culture across the region.

Tasks:

Promoting systems thinking to address complex, real-life problems and demonstrating how various modeling techniques can be used to tackle these issues through:

- **Capacity Building:** Offering a System Analytics Diploma.
- **International Publication.**
- **Awareness:** Raising awareness about the importance of systems thinking and analysis.
- **Participation:** Engaging in numerous international seminars, conferences, and workshops to highlight the practical applications of systems analysis in addressing real-world challenges.

The Economic Governance Unit

Goal:

The unit aims to develop national expertise capable of constructing and applying simulation models using the System Dynamics methodology to analyze complex dynamic economic, social, and environmental issues in light of alternative future scenarios. This effort is intended to support policymakers and planning officials across all governance levels.

Tasks:

- Studying and identifying complex and dynamic economic and social challenges in Egypt through modeling, simulation, and analysis, linking them to governance components.
- Analyzing national development policies using System Dynamics methodology and tools.
- Leveraging local, regional, and international expertise, integrating stakeholder opinions into the economic modeling and governance framework.
- Developing System Dynamics models and applying them within the national context to assist the government in addressing development challenges and implementing effective governance.
- Building models to analyze long-term development outcomes, generating various scenarios and alternatives essential for their implementation.
- Building capacity and preparing the necessary cadres to design more effective developmental policies.

The unit aims to enhance capacity building and skills in quantitative modeling, with the goal of applying these models in the research outputs produced by unit members. Additionally, the unit seeks to collaborate with Arab and international institutes to conduct joint training and research activities.

- The unit was established in collaboration with the Arab Planning Institute in Kuwait on 5th January 2023.

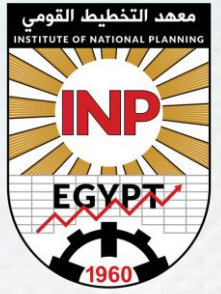
Research Activities:

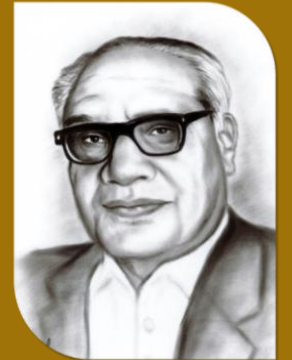
Second: The Institute of National Planning Seminar

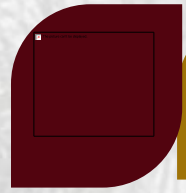

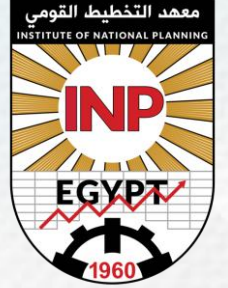

Academic Master's in Planning and Development



Aims of the Program

The Academic Master's in Planning and Development aims to prepare distinguished cadres in the field of planning and development, qualified to handle both international and local changes in their organizations, whether governmental or non-governmental, with the goal of fostering growth, improving efficiency, and increasing effectiveness. This is achieved by providing an innovative educational and training environment that blends scientific knowledge, expertise, and practical practices, while offering elements of creativity and future vision to achieve excellence.



Duration of the Program

Two academic years following the credit hour system with a total of 36 credit hours



Admission Requirements:

Applicants must hold a bachelor's degree from a university or scientific institute recognized by the Supreme Council of Universities, preferably in the field of Economics, with a minimum overall grade of "Good." Graduates from other disciplines—such as Commerce, Law, Media, Engineering, Science, Computer Science and Information, or Agriculture—or their equivalent degrees from accredited private universities and institutes may also be considered, provided they have achieved a minimum grade of "Very Good."

Additionally, candidates must successfully pass both the English language proficiency test and the computer skills assessment, as well as the personal interview.

The Professional Master's in Planning and Sustainable Development aims to equip students with the skills needed to prepare, follow up on, and evaluate plans, taking into account the goals of sustainable development.



Duration of the Program

Two Academic years



Registration Requirements

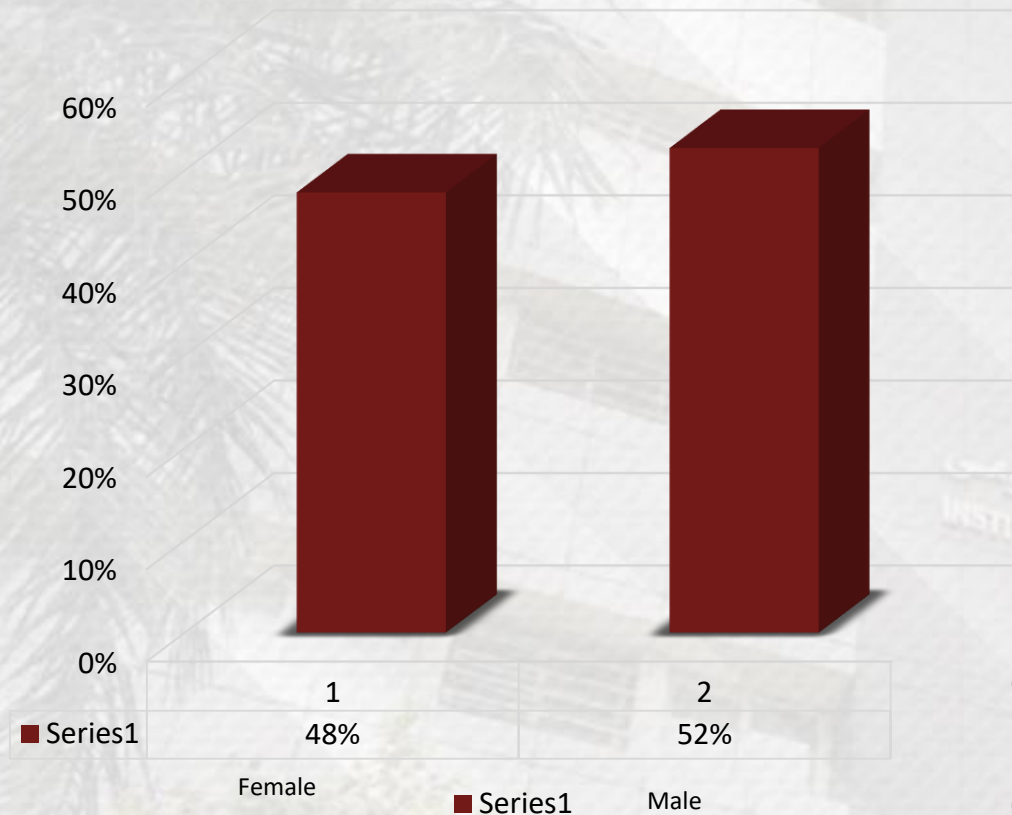

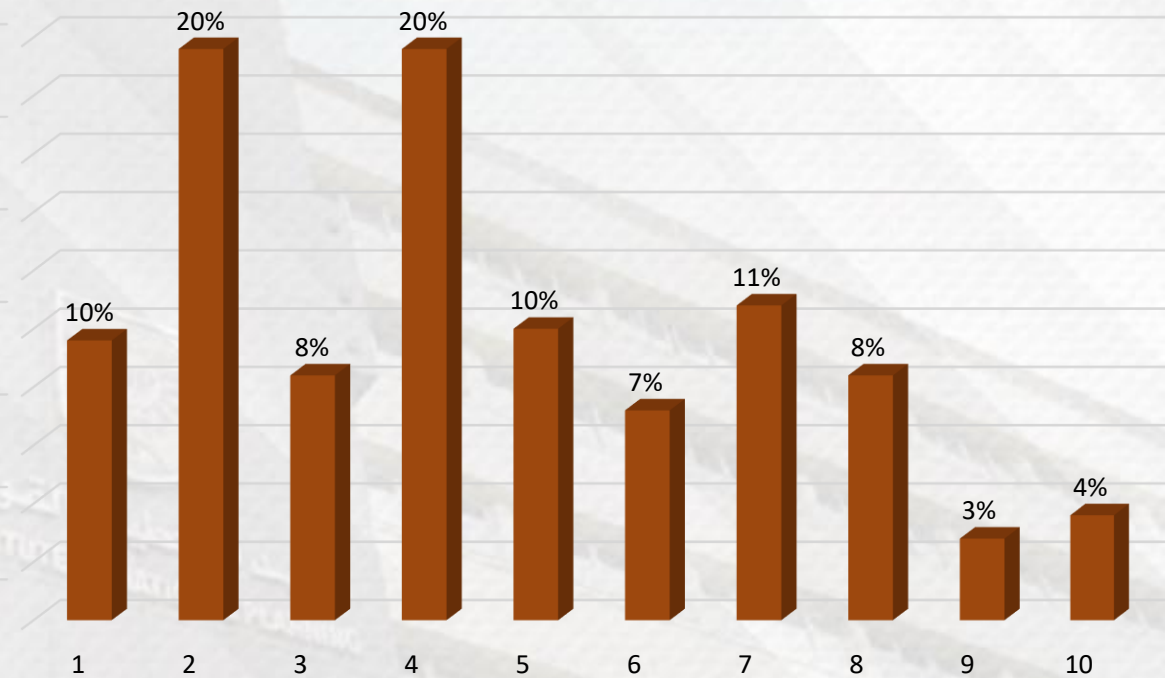
